TERMS AND CONDITIONS OF ENTRY
WHOLESALE AREA**

GENERAL

1. You enter and use this buyer undercover loading facility and car parking facility at your own risk.
2. You acknowledge that you understand that PML may record the undercover loading facility and car parking facility via its surveillance devices. You consent to any such recording.
3. By entering and allowing your vehicle to remain in a designated forklift parking bay, you consent to these terms and conditions of entry. If you do not accept these terms and conditions of entry, you must not enter the designated forklift parking bay.
4. You must:
 - a. only park your vehicle in designated bays that are appropriate for your vehicle and not park in any area which is not designated for your use;
 - b. park your vehicle wholly within the appropriate marked bay; and
 - c. comply with all parking signs, permit zones and directions issued to you by PML or its authorised officers.
 - d. Obtain and display a PML forklift registration number.
5. Vehicles must not stay in excess of 24 hours without the approval of PML (otherwise they may be deemed as abandoned).
6. PML reserves the right to change forklift parking bay availability at any time to meet safety or Market City Site management requirements;
7. The primary purpose of PML providing forklift parking bays is to facilitate Vehicle loading during CTA Market Operating Hours;
8. PML will allocate bays at its discretion, taking into account historic and expected usage patterns as well as compliance with these Market Rules and the payment of fees;
9. Forklift bays are available to registered or Authorised Buyers, Transporters or Growers only who must also possess an Access Card;
10. Forklift bays and surrounding areas are to be clear of all items (including produce and pallets) at all times.

TRANSHIPPING

Unless approved by PML in writing, each Person is prohibited from using the Buyers bays, Common Areas and other areas within the Market City Site as a staging post for the transshipment of Goods ultimately to a destination outside of the Market City Site to Persons who are not Tenants of the Market City Site.

FAILURE TO COMPLY

11. Vehicles not complying with these forklift parking bay terms and conditions of entry may be issued with a parking breach notice and PML will claim damages of \$50.00 from you.

12. PML or its authorised officers may direct the immediate removal of any vehicle from a car park and /or bay in their sole discretion (acting reasonably).

WARNING: TOW AWAY AND WHEEL CLAMP AREA

In addition to any other rights at law, if you fail to comply with these terms and conditions of entry, your vehicle may be;

- Towed to an impound facility; or
- Wheel clamped

At your expense.

If your vehicle is towed away and impounded or wheel clamped, you will be charged a fee for its release.

You must call (08) 9456 9215 to release your vehicle.

INSURANCE

13. You must:
 - a. have your forklift insured for at least 3rd party injury and damage at all times; and
 - b. provide evidence of this insurance to PML on request.

LIABILITY

14. PML is not responsible or liable for any for any of the following:
 - a. injury to you or anybody else;
 - b. damage to, destruction of, theft of or unauthorised delivery up of your vehicle or any other vehicle (authorised or not); or
 - c. damage to, destruction of, theft of or delivery up of any property (including anything in or on your vehicle or any other vehicle) however caused.

INDEMNITY AND RELEASE

15. You indemnify and release PML in respect of any claim made against PML as a consequence of, in relation to, or in any way arising out of your use of this forklift parking bay.

VISITORS

16. All visitors without an access card or parking permit must report to the Gate House at the Bannister Road entrance or go to PML reception.

OTHER

17. The PML Site Rules apply to all users of this car park and will form part of these terms and conditions of entry.

19. These terms and conditions of entry are in addition to any other terms and conditions that apply to your Market City access card or PML parking permit (as the case may be).
